The statutory auditors have carried out an audit of this financial results and has given unmodified opinion on the same.</p> <p>2) The Consolidated results has been prepared in accordance to Equity Method as per Ind AS and includes our share of Profit in the Joint Venture Company i.e. M/s Agro and Spice Trading Pte Ltd, Singapore and its subsidiaries. The results of the Joint Venture Company for the quarter ended December 31, 2025 have been approved by the Company's Board of Directors but have not been subject to Audit or Review.</p> <p>3) For the Financial Year 2025 -26, the Board has recommended a dividend of 10% i.e. Rs.0.20 Paise Per Shares subject to the approval of the shareholders in the ensuing Annual General Meeting.</p> <p>4) On November 21, 2025, the Government of India has implemented four new Labour Codes (the Labour Codes), including the Code on Wages, 2019, which amended the definition of wages. Based on the best information available, the company carried out the estimation of gratuity and long-term compensated absences and recorded a provision of Rs. 13.63 Lakhs primarily arising from the change in "wages" definition.
